With reference to the subject cited above, I am directed to say that an Integrated Control Room for Emergency Response (ICR-ER) is being setup in Ministry of Home Affairs to ameliorate the efficiency of handling natural disasters and emergency situations with situational awareness and strategic level monitoring.

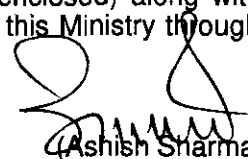
2. ICR-ER is the state-of-the-art architecture with unique geo-spatial database framework to disseminate space-based inputs along with services of forecasting organizations addressing all natural disasters in all phases at pan India level coupled with decision support system (DSS) tools. ICR-ER will coordinate multi-institutional participation to assist the decision makers, disaster management officials of all States/UTs, NDRF/SDRF for preparedness, hazard/risk zonation, damage assessment and emergency response. The data received from field and EOS (Earth Observation Satellites) is visualised in ICR-ER and showcased on at control room Video walls for further planning for decision makers.

3. Keeping in view the functional requirement of ICR-ER, this Ministry is in process of filling 25 various posts on deputation basis from various Central Armed Police Forces (CAPFs). The Qualitative Requirements for these posts are enclosed. The candidates will be selected by a four-members selection committee headed by Additional Secretary (Disaster Management), MHA. The initial deputation period will be 03 years, and further extension will be with discretion of selection committee and in accordance with DOPT's O.M. no. 6/8/2009-Estt. (Pay.II) dated 17.06.2010 and O.M. no. 2/6/2018-Estt. (Pay.II) dated 18.05.2018. The details of rank, level of pay and no. of posts are as under:
